



**Monthly Draft Agreement:**

The Middlecreek Area Community Center (MACC) monthly draft is a continuous membership plan. I understand that this membership will remain in effect until I give a 30 day written notice. It is my complete understanding that if I wish to terminate or change my membership I must give the MACC a 30 day written notice \_\_\_\_\_(initial here)

The MACC Board of Directors may, at their discretion, adjust the monthly rate applicable to my category of membership. I understand that I will receive at least 4 weeks notice prior to any such change \_\_\_\_\_(initial here)

Should any membership payment not be honored by my bank or credit card company for any reason, I realize that I am still responsible for that payment plus a service charge applied by the MACC. This is in addition to any service fee my bank may charge. Members who elect to pay by bank draft or credit card will be limited to three non-sufficient funds transactions. Upon the third, the account will be reviewed by the Executive Director and loss of bank draft privileges will be considered \_\_\_\_\_(initial here)

**Monthly Draft Authorization:**

I hereby request and authorize the MACC to charge my account for monthly membership fees through an automatic payment. I agree that the MACC’s rights in respect to such payment shall be the same as if it were a check drawn and signed personally by me \_\_\_\_\_(initial here)

**Monthly Draft Cancellation:**

For cancellations to occur, you must give the MACC a 30 day written notice \_\_\_\_\_(initial here)

**Membership Agreement:**

The Middlecreek Area Community Center prohibits inappropriate behavior and conduct. This includes, but is not limited to, profanity or abusive language, attire, smoking, use of alcohol or drugs, the damage or removal of MACC property, or prior or current criminal conduct of any type. Such inappropriate behavior or conduct is unacceptable and the MACC consequently retains the right to deny memberships to its applicants or revoke a membership of any current member or participant at its sole discretion. The MACC conducts regular sex offender screenings on all members, participants, and guests. If a sex offender match occurs, the MACC reserves the right to cancel membership, end program participation, and remove visitation access.

**Liability Waiver:**

By participating in the MACC Membership Program, the undersigned and immediate family agrees to release the Middlecreek Area Community Center and the West Snyder Recreation Association, from claims of negligence for bodily injury or death in connection with the use of MACC facilities, and from any liability for other claims, including loss of property, to the fullest extent of the law.

**Refund Policy:**

Memberships are **not** refundable.
